Good morning,

This is a message from the Illinois Small Business Development Center of McLean County at Illinois Wesleyan University to SBDC Clients and to the public of McLean County, Illinois.

Our center is relaying this update just announcement by Governor JB Pritzker at yesterday's daily briefing. See full press release here.

Under the leadership of Governor JB Pritzker, DCEO is working with partners to launch three emergency assistance programs for Illinois small businesses. These initiatives include:

Hospitality Emergency Grant Program

To help hospitality businesses make ends meet in the midst of the COVID-19 pandemic, DCEO is launching the Hospitality Emergency Grant Program with \$14 million drawn from funds originally budgeted for job training, tourism promotion, and other purposes.

- Grant funds are available to support working capital such as payroll and rent, as well as job training, retraining, and technology to support shifts in operations, like increased pickup and delivery.
- Bars and restaurants that generated between \$500K and \$1M in revenue in 2019 are eligible for up to \$25,000.
- Bars and restaurants that generated less than \$500K in revenue in 2019 are eligible for up to \$10,000.
- Hotels that generated less than \$8M in revenue in 2019 are eligible for up to \$50,000.
- IMPORTANT:
 - Businesses can submit an application online via the DCEO website here (in English or Spanish).
 - Applications for awards will be accepted until 5:00pm on April 1st
 - Winners will be chosen via a lottery, therefore, there is no benefit to submitting an application first as long as a valid, complete application is received by the deadline.

Illinois Small Business Emergency Loan Fund

- DCEO and the Illinois Department of Financial and Professional Regulation (IDFPR) are establishing the Illinois Small Business Emergency Loan Fund to offer small businesses low interest loans of up to \$50,000.
- Businesses located outside of the City of Chicago with fewer than 50 workers and less than \$3 million in revenue in 2019 will be eligible to apply.
- Successful applicants will owe nothing for six months, and will then begin making fixed payments at a below market interest rate for the remainder of a five-year loan term.
- <u>İMPORTANT:</u>
 - Starting this Friday, March 27th, interested businesses will be able to express interest at a form that will be posted on the **DCEO website here**

Downstate Small Business Stabilization Program

- To support small businesses in downstate and rural counties across Illinois, DCEO is repurposing \$20 million in CDBG funds to stand up the Downstate Small Business Stabilization Program.
- This Fund will offer small businesses of up to 50 employees the opportunity to partner with their local governments to obtain grants of up to \$25,000 in working capital.
- These grants will be offered on a rolling basis.

 IMPORTANT:
- - Local governments can apply on behalf of businesses with 50 employees or less.
 - Only units of local government recognized by the Illinois Constitution and able to support economic development activities on a sufficient scale are eligible to apply for Economic Development grant funding. This includes cities, villages, and counties. Municipalities must not be a HUD direct Entitlement community or be located in an urban county that receives "entitlement" funds.
 - A map of eligible areas of the state can be accessed on the **DCEO website**, see "Staff Contact Information."
 - Businesses in the eligible areas should work with their local governments to submit applications.
 - Application materials will be posted to the DCEO website here this Friday, March 27, 2020.

Additional updates for small business owners related to COVID-19:

- 1. Governor JB Pritzker also announced the extension of Illinois State Income Tax filing to July 15th to match the IRS federal change. See press release here.
- Governor JB Pritzker announced a sales tax deferral for bars and restaurants.
- 3. The Families First Coronavirus Response Act was signed into law to aid families and businesses across the U.S.
- 4. A third Coronavirus bill aimed to give cash directly to Americans starts negotiations.
- 5. SBA Economic Injury Disaster Loans are available (as of 3/19) to small businesses and private non-profits affected by the COVID-19 pandemic.
